THIS MODEL ANTICIPATED THE DECENTRALIZED, USER-GENERATED CONTENT ETHOS OF THE MODERN INTERNET.

THE CATALOG'S TAGLINE, "ACCESS TO TOOLS," ENCAPSULATED A PHILOSOPHY THAT VALUED ENABLING INDIVIDUALS TO SHAPE THEIR OWN ENVIRONMENTS—A PRINCIPLE THAT RESONATES DEEPLY IN TODAY'S MAKER CULTURE AND OPEN-SOURCE COMMUNITIES.

Actor Marlon Brando and comedian Dick Gregory spoke about the problems Native Americans faced. For their part, Indians understood they could not achieve political change without help. Non-Indians had to be educated and enlisted. Smith shows how Indians found, among this hodge-podge of dissatisfied Americans, willing recruits to their campaign for recognition of treaty rights; realization of tribal power, sovereignty, and self-determination; and protection of reservations as cultural homelands. The coalition was ephemeral but significant, leading to political reforms that strengthened Indian sovereignty. Thoroughly researched and vividly written, this book not only illuminates this transformative historical moment but contributes greatly to our understanding of social movements.
