STUDENTS COME FROM VARIED BACKGROUNDS WITH DIFFERENT LEVELS OF PRIOR KNOWLEDGE AND LEARNING STYLES. CIVICS AND ECONOMICS TEXTBOOKS SHOULD ACCOMMODATE THIS DIVERSITY THROUGH DIFFERENTIATED INSTRUCTION STRATEGIES, ACCESSIBLE LANGUAGE, AND CULTURALLY RELEVANT EXAMPLES.

IMPACT OF CIVICS AND ECONOMICS TEXTBOOKS ON STUDENT OUTCOMES

RESEARCH INDICATES THAT COMPREHENSIVE CIVICS AND ECONOMICS EDUCATION CORRELATES WITH HIGHER LEVELS OF CIVIC ENGAGEMENT AND FINANCIAL LITERACY AMONG STUDENTS. FOR EXAMPLE, A STUDY PUBLISHED BY THE NATIONAL ASSESSMENT OF EDUCATIONAL PROGRESS (NAEP) FOUND THAT STUDENTS WITH ACCESS TO WELL-STRUCTURED CIVICS CURRICULA DEMONSTRATED BETTER UNDERSTANDING OF GOVERNMENTAL PROCESSES AND WERE MORE LIKELY TO PARTICIPATE IN COMMUNITY ACTIVITIES.

SIMILARLY, ECONOMICS EDUCATION HAS BEEN LINKED TO IMPROVED PERSONAL FINANCIAL DECISION-MAKING SKILLS, AN INCREASINGLY IMPORTANT COMPETENCY IN A WORLD OF COMPLEX CREDIT SYSTEMS, INVESTMENT OPTIONS, AND GLOBAL MARKETS.

- INVEST IN HIGH-QUALITY, EVIDENCE-BASED CIVICS AND ECONOMICS TEXTBOOKS THAT ADHERE TO RIGOROUS ACADEMIC STANDARDS.
- ENSURE TRAINING FOR TEACHERS TO EFFECTIVELY USE TEXTBOOKS AS PART OF A BROADER, INTERACTIVE CURRICULUM.
- INCORPORATE DIVERSE PERSPECTIVES AND REAL-WORLD ISSUES TO FOSTER CRITICAL THINKING AND INCLUSIVITY.
- LEVERAGE DIGITAL RESOURCES TO SUPPLEMENT PRINT MATERIALS AND KEEP CONTENT CURRENT.
