3. NAVIGATION AND FLIGHT PLANNING

UNDERSTANDING AIRCRAFT WEIGHT AND BALANCE, TAKEOFF AND LANDING PERFORMANCE, AND OTHER OPERATIONAL PARAMETERS IS ESSENTIAL. QUESTIONS MAY INVOLVE INTERPRETING CHARTS AND MAKING DECISIONS BASED ON AIRCRAFT CAPABILITIES IN VARYING CONDITIONS.

5. EMERGENCY PROCEDURES AND COMMUNICATIONS

THE TEST ALSO EVALUATES YOUR KNOWLEDGE OF HANDLING IN-FLIGHT EMERGENCIES, COMMUNICATION PROTOCOLS, AND COORDINATION WITH AIR TRAFFIC CONTROL AND FLIGHT CREWS.

EXAM FORMAT AND CONTENT BREAKDOWN
