LOCATION ISN'T JUST A BUZZWORD

YOU'VE PROBABLY HEARD THE PHRASE "LOCATION, LOCATION, LOCATION" COUNTLESS TIMES, AND THERE'S A GOOD REASON FOR IT. THE REAL OF REAL ESTATE SHOWS US THAT LOCATION IS THE SINGLE MOST CRITICAL FACTOR DETERMINING PROPERTY VALUE. PROXIMITY TO SCHOOLS, WORKPLACES, PUBLIC TRANSPORTATION, AMENITIES, AND EVEN FUTURE DEVELOPMENT PLANS CAN DRAMATICALLY AFFECT PRICES.

FOR EXAMPLE, A HOME NEAR A HIGHLY-RATED SCHOOL DISTRICT CAN COMMAND A PREMIUM SIMPLY BECAUSE FAMILIES ARE WILLING TO PAY MORE FOR QUALITY EDUCATION ACCESS. SIMILARLY, PROPERTIES CLOSE TO TRANSIT HUBS OR MAJOR HIGHWAYS OFTEN SEE HIGHER DEMAND BECAUSE THEY REDUCE COMMUTE TIMES, A SIGNIFICANT CONSIDERATION IN TODAY'S FAST-PACED WORLD.

MARKET CYCLES AND TIMING

IN RESPONSE, DEVELOPERS AND INVESTORS HAVE HAD TO RETHINK PROPERTY USAGE AND DESIGN. ADAPTIVE REUSE PROJECTS—CONVERTING OFFICE BUILDINGS INTO RESIDENTIAL UNITS, FOR EXAMPLE—HAVE GAINED TRACTION. LIKEWISE, HEALTH AND WELLNESS FEATURES IN BUILDINGS HAVE BECOME SELLING POINTS, EMPHASIZING AIR QUALITY, NATURAL LIGHTING, AND COMMUNAL SPACES THAT FACILITATE SOCIAL DISTANCING.

DATA-DRIVEN INSIGHTS POST-PANDEMIC

ACCORDING TO RECENT REPORTS, SUBURBAN HOME SALES INCREASED BY APPROXIMATELY 15% YEAR-OVER-YEAR IN SEVERAL COUNTRIES, WHILE OFFICE VACANCY RATES IN MAJOR CITIES ROSE SIGNIFICANTLY.
