THE GLOBAL STRUGGLE FOR HUMAN RIGHTS: CHALLENGES, PROGRESS, AND HOPE

THE GLOBAL STRUGGLE FOR HUMAN RIGHTS IS ONE OF THE MOST PROFOUND AND ENDURING EFFORTS SHAPING OUR MODERN WORLD. FROM THE EARLIEST DECLARATIONS OF DIGNITY AND FREEDOM TO THE ONGOING FIGHTS AGAINST OPPRESSION AND INJUSTICE, THIS BATTLE TRANSCENDS BORDERS AND CULTURES, UNITING PEOPLE AROUND A SHARED VISION OF EQUALITY AND RESPECT. BUT WHY DOES THIS STRUGGLE PERSIST, AND WHAT DOES IT TRULY MEAN TO UPHOLD HUMAN RIGHTS IN TODAY'S COMPLEX GLOBAL LANDSCAPE? LET'S EXPLORE THE NUANCES, CHALLENGES, AND INSPIRING STRIDES WITHIN THIS UNIVERSAL CAUSE.

UNDERSTANDING THE GLOBAL STRUGGLE FOR HUMAN RIGHTS

HUMAN RIGHTS REPRESENT THE FUNDAMENTAL FREEDOMS AND PROTECTIONS EVERY INDIVIDUAL IS ENTITLED TO, SIMPLY BY BEING HUMAN. THESE INCLUDE RIGHTS SUCH AS FREEDOM OF SPEECH, THE RIGHT TO EDUCATION, PROTECTION FROM TORTURE, AND EQUAL TREATMENT UNDER THE LAW. HOWEVER, DESPITE WIDESPREAD INTERNATIONAL AGREEMENTS, MILLIONS WORLDWIDE STILL FACE VIOLATIONS THAT STRIP AWAY THESE BASIC ENTITLEMENTS.

HISTORICAL ROOTS AND EVOLUTION

THE FIGHT FOR HUMAN RIGHTS IS FAR FROM NEW. LANDMARK MOMENTS LIKE THE MAGNA CARTA IN 1215, THE ABOLITION OF SLAVERY IN THE 19TH CENTURY, AND THE UNIVERSAL DECLARATION OF HUMAN RIGHTS (UDHR) IN 1948 LAID CRUCIAL GROUNDWORK. THE UDHR, ADOPTED BY THE UNITED NATIONS, MARKED A GLOBAL CONSENSUS ON THE RIGHTS EVERYONE DESERVES, REGARDLESS OF NATIONALITY, RACE, OR CREED.

YET, HISTORY ALSO REMINDS US OF DARK CHAPTERS—GENOCIDE, COLONIALISM, APARTHEID—THAT UNDERScore HOW FRAGILE THESE RIGHTS CAN BE. THE GLOBAL STRUGGLE FOR HUMAN RIGHTS IS, THEREFORE, NOT JUST ABOUT CELEBRATING PROGRESS BUT ALSO CONFRONTING PERSISTENT INJUSTICES AND SYSTEMIC ABUSES.

CONTEMPORARY CHALLENGES IN THE GLOBAL STRUGGLE FOR HUMAN RIGHTS

WHILE MANY NATIONS HAVE RATIFIED HUMAN RIGHTS TREATIES, ENFORCEMENT REMAINS UNEVEN. POLITICAL INSTABILITY, AUTHORITARIAN REGIMES, AND ECONOMIC DISPARITIES OFTEN FUEL VIOLATIONS AND HINDER ACCOUNTABILITY.

AUTHORITARIANISM AND SUPPRESSION OF FREEDOMS

IN COUNTRIES WHERE GOVERNMENTS CONSOLIDATE POWER, DISSENT IS FREQUENTLY MET WITH CENSORSHIP, IMPRISONMENT, OR WORSE. FREEDOM OF EXPRESSION AND THE PRESS—VITAL PILLARS OF DEMOCRACY—ARE CURTAILED, LEAVING CITIZENS VULNERABLE AND VOICELESS. ACTIVISTS AND JOURNALISTS WHO DARE TO EXPOSE CORRUPTION OR HUMAN RIGHTS ABUSES OFTEN FACE INTIMIDATION OR VIOLENCE.

DISCRIMINATION AND INEQUALITY

DISCRIMINATION BASED ON RACE, GENDER, RELIGION, OR SEXUAL ORIENTATION REMAINS A MAJOR HURDLE. FOR EXAMPLE, WOMEN AND LGBTQ+ INDIVIDUALS FREQUENTLY ENCOUNTER SYSTEMIC BARRIERS LIMITING THEIR ACCESS TO EDUCATION, HEALTHCARE, OR EMPLOYMENT. THE GLOBAL STRUGGLE FOR HUMAN RIGHTS INCLUDES ADDRESSING SUCH INTERSECTIONAL INEQUALITIES THAT CUT ACROSS CULTURES AND ECONOMIES.

REFUGEE CRISES AND FORCED DISPLACEMENT

WARS, PERSECUTION, AND ENVIRONMENTAL DISASTERS HAVE GENERATED UNPRECEDENTED NUMBERS OF REFUGEES AND INTERNALLY DISPLACED PERSONS. THESE VULNERABLE POPULATIONS OFTEN LACK ACCESS TO BASIC SERVICES AND PROTECTIONS, AND THEIR PLIGHT HIGHLIGHTS THE URGENT NEED FOR INTERNATIONAL COOPERATION AND HUMANITARIAN RESPONSE WITHIN THE HUMAN RIGHTS FRAMEWORK.

INTERNATIONAL MECHANISMS AND THEIR ROLE

GLOBAL INSTITUTIONS PLAY A PIVOTAL ROLE IN PROMOTING AND SAFEGUARDING HUMAN RIGHTS, BUT THEIR EFFECTIVENESS CAN SOMETIMES BE QUESTIONED.

THE UNITED NATIONS AND HUMAN RIGHTS COUNCILS

THE UN HUMAN RIGHTS COUNCIL AND RELATED BODIES MONITOR ABUSES, ISSUE REPORTS, AND RECOMMEND ACTIONS. THEY ALSO FACILITATE DIALOGUE AMONG MEMBER STATES TO BUILD CONSENSUS ON HUMAN RIGHTS ISSUES. HOWEVER, GEOPOLITICAL INTERESTS SOMETIMES HINDER DECISIVE ACTION, ESPECIALLY WHEN POWERFUL NATIONS ARE IMPLICATED.

NON-GOVERNMENTAL ORGANIZATIONS (NGOs)

NGOs SUCH AS AMNESTY INTERNATIONAL AND HUMAN RIGHTS WATCH OPERATE ON THE FRONTLINES, DOCUMENTING ABUSES AND ADVOCATING FOR VICTIMS. THEIR WORK RAISES AWARENESS AND PRESSURES GOVERNMENTS TO UPHOLD INTERNATIONAL STANDARDS. GRASSROOTS ORGANIZATIONS ALSO EMPOWER LOCAL COMMUNITIES TO DEMAND THEIR RIGHTS AND PARTICIPATE ACTIVELY IN GOVERNANCE.

TECHNOLOGY'S DOUBLE-EDGED SWORD IN THE HUMAN RIGHTS ARENA

IN TODAY'S DIGITAL AGE, TECHNOLOGY PROFOUNDLY IMPACTS THE GLOBAL STRUGGLE FOR HUMAN RIGHTS, PRESENTING BOTH OPPORTUNITIES AND RISKS.

AMPLIFYING VOICES AND MOBILIZING CHANGE

SOCIAL MEDIA PLATFORMS HAVE REVOLUTIONIZED ACTIVISM BY PROVIDING TOOLS TO EXPOSE VIOLATIONS, ORGANIZE PROTESTS, AND RALLY INTERNATIONAL SUPPORT RAPIDLY. CAMPAIGNS AGAINST INJUSTICES CAN GAIN GLOBAL TRACTION WITHIN HOURS, SHINING A SPOTLIGHT ON ISSUES PREVIOUSLY IGNORED.

SURVEILLANCE, PRIVACY, AND DIGITAL REPRESSION

CONVERSELY, AUTHORITARIAN REGIMES INCREASINGLY EXPLOIT TECHNOLOGY FOR MASS SURVEILLANCE, CENSORSHIP, AND DISINFORMATION CAMPAIGNS. THIS DIGITAL REPRESSION THREATENS PRIVACY AND RESTRICTS FREE EXPRESSION, COMPLICATING THE FIGHT FOR HUMAN RIGHTS IN CYBERSPACE.

STEPS TOWARD STRENGTHENING THE GLOBAL STRUGGLE FOR HUMAN RIGHTS

WHILE THE CHALLENGES ARE DAUNTING, THERE ARE MEANINGFUL STRATEGIES AND ACTIONS THAT CAN ADVANCE THE CAUSE WORLDWIDE.

EDUCATION AND AWARENESS

PROMOTING HUMAN RIGHTS EDUCATION AT ALL LEVELS FOSTERS A CULTURE OF RESPECT AND EMPATHY. WHEN PEOPLE UNDERSTAND THEIR RIGHTS AND THOSE OF OTHERS, THEY ARE BETTER EQUIPPED TO CHALLENGE ABUSES AND ADVOCATE FOR JUSTICE.

BUILDING INCLUSIVE INSTITUTIONS

STRONG, TRANSPARENT INSTITUTIONS THAT REPRESENT DIVERSE POPULATIONS HELP ENSURE LAWS AND POLICIES PROTECT EVERYONE FAIRLY. ENCOURAGING CIVIC PARTICIPATION AND HOLDING LEADERS ACCOUNTABLE ARE CRUCIAL COMPONENTS.

INTERNATIONAL SOLIDARITY AND COOPERATION

NO COUNTRY CAN SOLVE HUMAN RIGHTS ISSUES IN ISOLATION. COLLABORATIONS BETWEEN GOVERNMENTS, CIVIL SOCIETY, AND INTERNATIONAL BODIES ENHANCE RESOURCE-SHARING, EXPERTISE, AND PRESSURE MECHANISMS TO PROMOTE COMPLIANCE WITH HUMAN RIGHTS NORMS.

SUPPORT FOR VULNERABLE GROUPS

TARGETED PROGRAMS TO EMPOWER MARGINALIZED COMMUNITIES—SUCH AS WOMEN, MINORITIES, REFUGEES, AND PERSONS WITH DISABILITIES—HELP REDUCE SYSTEMIC DISPARITIES AND ENABLE FULL PARTICIPATION IN SOCIETY.

STORIES OF HOPE: HUMAN RIGHTS VICTORIES AROUND THE WORLD

AMIDST ONGOING STRUGGLES, INSPIRING STORIES REMIND US OF THE RESILIENCE AND COURAGE FUELING CHANGE.

IN SOUTH AFRICA, THE END OF APARTHEID MARKED A MONUMENTAL VICTORY FOR RACIAL EQUALITY AND JUSTICE. THE CIVIL RIGHTS MOVEMENTS IN THE UNITED STATES HELPED DISMANTLE SEGREGATION AND EXPANDED VOTING RIGHTS. MORE RECENTLY, YOUTH-LED MOVEMENTS ADVOCATING FOR CLIMATE JUSTICE AND GENDER EQUALITY ILLUSTRATE THE EVOLVING NATURE OF HUMAN RIGHTS ACTIVISM.

THESE SUCCESSES DEMONSTRATE THAT PERSISTENT EFFORTS, EVEN IN THE FACE OF ADVERSITY, CAN TRANSFORM SOCIETIES AND AFFIRM THE INHERENT DIGNITY OF ALL PEOPLE.

THE GLOBAL STRUGGLE FOR HUMAN RIGHTS IS A LIVING, BREATHING ENDEAVOR THAT CONTINUES TO EVOLVE. IT CHALLENGES EACH OF US TO RECOGNIZE OUR SHARED HUMANITY AND TO ACT—WHETHER BY RAISING AWARENESS, SUPPORTING ADVOCACY GROUPS, OR SIMPLY STANDING UP FOR FAIRNESS IN OUR COMMUNITIES. WHILE THE PATH IS COMPLEX AND SOMETIMES PERILOUS, THE PURSUIT OF A WORLD WHERE EVERYONE'S RIGHTS ARE RESPECTED REMAINS A BEACON OF HOPE AND A COMMON GOAL WORTH FIGHTING FOR.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE MOST PRESSING HUMAN RIGHTS ISSUES GLOBALLY TODAY?

THE MOST PRESSING HUMAN RIGHTS ISSUES TODAY INCLUDE THE SUPPRESSION OF FREEDOM OF SPEECH, SYSTEMIC RACISM, GENDER INEQUALITY, REFUGEE CRISES, AND VIOLATIONS OF PRIVACY AND DIGITAL RIGHTS.

HOW DO INTERNATIONAL ORGANIZATIONS CONTRIBUTE TO THE GLOBAL STRUGGLE FOR HUMAN RIGHTS?

INTERNATIONAL ORGANIZATIONS LIKE THE UNITED NATIONS, AMNESTY INTERNATIONAL, AND HUMAN RIGHTS WATCH MONITOR VIOLATIONS, ADVOCATE FOR POLICY CHANGES, PROVIDE HUMANITARIAN AID, AND HOLD GOVERNMENTS ACCOUNTABLE THROUGH REPORTS AND SANCTIONS.

WHAT ROLE DOES TECHNOLOGY PLAY IN ADVANCING OR HINDERING HUMAN RIGHTS GLOBALLY?

TECHNOLOGY FACILITATES THE SPREAD OF INFORMATION, MOBILIZES ACTIVISM, AND PROMOTES TRANSPARENCY, BUT IT CAN ALSO BE USED FOR SURVEILLANCE, CENSORSHIP, AND SPREADING MISINFORMATION, IMPACTING HUMAN RIGHTS BOTH POSITIVELY AND NEGATIVELY.

HOW HAS THE COVID-19 PANDEMIC AFFECTED THE GLOBAL STRUGGLE FOR HUMAN RIGHTS?

THE COVID-19 PANDEMIC HAS EXACERBATED INEQUALITIES, RESTRICTED FREEDOMS THROUGH LOCKDOWNS AND EMERGENCY LAWS, AND HIGHLIGHTED DISPARITIES IN HEALTHCARE ACCESS, WHILE ALSO PROMPTING CALLS FOR STRONGER SOCIAL PROTECTIONS AND EQUITABLE VACCINE DISTRIBUTION.

WHY IS IT IMPORTANT FOR COUNTRIES TO UPHOLD INTERNATIONAL HUMAN RIGHTS TREATIES?

UPHOLDING INTERNATIONAL HUMAN RIGHTS TREATIES ENSURES THE PROTECTION OF FUNDAMENTAL FREEDOMS, PROMOTES JUSTICE AND EQUALITY, FOSTERS PEACE AND STABILITY, AND STRENGTHENS GLOBAL COOPERATION TO PREVENT ABUSES AND SUPPORT VICTIMS.

ADDITIONAL RESOURCES

THE GLOBAL STRUGGLE FOR HUMAN RIGHTS: AN ONGOING QUEST FOR JUSTICE AND DIGNITY

THE GLOBAL STRUGGLE FOR HUMAN RIGHTS REMAINS ONE OF THE MOST PRESSING AND COMPLEX ISSUES CONFRONTING SOCIETIES TODAY. DESPITE CONSIDERABLE PROGRESS SINCE THE ADOPTION OF THE UNIVERSAL DECLARATION OF HUMAN RIGHTS IN 1948, MILLIONS AROUND THE WORLD CONTINUE TO FACE SYSTEMIC VIOLATIONS OF THEIR FUNDAMENTAL FREEDOMS. THIS ENDURING CONFLICT BETWEEN IDEALS AND REALITIES UNDERSCORES THE MULTIFACETED NATURE OF HUMAN RIGHTS ADVOCACY, WHICH INTERSECTS WITH POLITICAL, ECONOMIC, SOCIAL, AND CULTURAL DIMENSIONS GLOBALLY. AS NATIONS GRAPPLE WITH AUTHORITARIANISM, INEQUALITY, AND EMERGING TECHNOLOGIES, THE PURSUIT OF UNIVERSAL HUMAN DIGNITY IS INCREASINGLY CHALLENGED BUT NO LESS VITAL.

UNDERSTANDING THE SCOPE OF THE GLOBAL HUMAN RIGHTS STRUGGLE

THE GLOBAL STRUGGLE FOR HUMAN RIGHTS ENCOMPASSES A BROAD SPECTRUM OF ISSUES, FROM POLITICAL REPRESSION AND

RACIAL DISCRIMINATION TO ECONOMIC INEQUALITY AND GENDER-BASED VIOLENCE. IT IS A DYNAMIC ARENA WHERE INTERNATIONAL LAW, GRASSROOTS MOVEMENTS, AND GEOPOLITICAL INTERESTS CONVERGE. THE UNITED NATIONS AND VARIOUS NON-GOVERNMENTAL ORGANIZATIONS (NGOs) PLAY PIVOTAL ROLES IN MONITORING ABUSES AND PROMOTING ACCOUNTABILITY, YET ENFORCEMENT MECHANISMS OFTEN FALL SHORT, ESPECIALLY WHEN SOVEREIGN INTERESTS OVERRIDE MORAL IMPERATIVES.

ONE SIGNIFICANT CHALLENGE LIES IN THE UNEVEN APPLICATION AND RECOGNITION OF RIGHTS ACROSS REGIONS. FOR EXAMPLE, FREEDOM OF SPEECH AND ASSEMBLY MAY BE CONSTITUTIONALLY GUARANTEED IN DEMOCRATIC STATES BUT SUPPRESSED UNDER AUTOCRATIC REGIMES. MEANWHILE, ECONOMIC, SOCIAL, AND CULTURAL RIGHTS—SUCH AS ACCESS TO EDUCATION, HEALTHCARE, AND ADEQUATE LIVING STANDARDS—ARE FREQUENTLY NEGLECTED IN BOTH DEVELOPING AND DEVELOPED COUNTRIES ALIKE. THESE DISPARITIES ILLUSTRATE HOW HUMAN RIGHTS STRUGGLES ARE NOT CONFINED TO ANY SINGLE GEOGRAPHY OR POLITICAL SYSTEM BUT ARE A GLOBAL PHENOMENON SHAPED BY LOCAL CONTEXTS.

POLITICAL REPRESSION AND THE FIGHT FOR CIVIL LIBERTIES

AT THE HEART OF MANY HUMAN RIGHTS CONFLICTS IS THE BATTLE FOR CIVIL AND POLITICAL RIGHTS. AUTHORITARIAN GOVERNMENTS OFTEN STIFLE DISSENT THROUGH CENSORSHIP, ARBITRARY DETENTION, AND VIOLENCE AGAINST ACTIVISTS. ACCORDING TO THE 2023 FREEDOM IN THE WORLD REPORT BY FREEDOM HOUSE, OVER 40% OF COUNTRIES EXPERIENCED DECLINES IN POLITICAL RIGHTS AND CIVIL LIBERTIES, MARKING THE 17TH CONSECUTIVE YEAR OF GLOBAL DETERIORATION.

IN PLACES LIKE MYANMAR, BELARUS, AND HONG KONG, PRO-DEMOCRACY PROTESTS HAVE BEEN MET WITH BRUTAL CRACKDOWNS, EXEMPLIFYING THE HIGH STAKES OF CIVIC ENGAGEMENT. CONVERSELY, SOME NATIONS HAVE SEEN ADVANCES IN JUDICIAL INDEPENDENCE AND ELECTORAL TRANSPARENCY, HIGHLIGHTING THAT PROGRESS IS POSSIBLE WHEN DOMESTIC INSTITUTIONS AND INTERNATIONAL PRESSURE ALIGN.

ECONOMIC AND SOCIAL RIGHTS: THE UNDEREXPLORED FRONTLINE

WHILE POLITICAL RIGHTS OFTEN DOMINATE HEADLINES, ECONOMIC AND SOCIAL RIGHTS FORM THE BEDROCK OF HUMAN DIGNITY. THE GLOBAL STRUGGLE FOR HUMAN RIGHTS INCREASINGLY ACKNOWLEDGES THE INSEPARABILITY OF THESE DIMENSIONS. ACCESS TO HEALTHCARE, EDUCATION, AND ADEQUATE HOUSING ARE CRITICAL FOR INDIVIDUALS TO EXERCISE THEIR FREEDOMS EFFECTIVELY.

THE COVID-19 PANDEMIC EXPOSED AND EXACERBATED EXISTING INEQUALITIES, WITH MARGINALIZED COMMUNITIES DISPROPORTIONATELY AFFECTED BY HEALTH CRISES AND ECONOMIC DISRUPTIONS. THE WORLD BANK ESTIMATES THAT THE PANDEMIC PUSHED AN ADDITIONAL 97 MILLION PEOPLE INTO EXTREME POVERTY BY 2022, UNDERSCORING THE URGENCY OF INTEGRATING SOCIAL RIGHTS INTO HUMAN RIGHTS FRAMEWORKS.

MOREOVER, LABOR RIGHTS REMAIN A CONTENTIOUS ARENA, ESPECIALLY IN SUPPLY CHAINS SPANNING MULTIPLE COUNTRIES. EXPLOITATIVE WORKING CONDITIONS AND CHILD LABOR PERSIST IN VARIOUS INDUSTRIES, CHALLENGING MULTINATIONAL CORPORATIONS AND GOVERNMENTS TO ENFORCE ETHICAL STANDARDS MORE RIGOROUSLY.

KEY ACTORS AND MECHANISMS IN THE HUMAN RIGHTS LANDSCAPE

THE GLOBAL STRUGGLE FOR HUMAN RIGHTS INVOLVES A COMPLEX WEB OF ACTORS, INCLUDING INTERNATIONAL BODIES, STATE INSTITUTIONS, CIVIL SOCIETY, AND THE PRIVATE SECTOR. EACH PLAYS DISTINCT YET INTERRELATED ROLES IN ADVANCING OR IMPEDING HUMAN RIGHTS PROTECTIONS.

INTERNATIONAL ORGANIZATIONS AND LEGAL FRAMEWORKS

THE UNITED NATIONS REMAINS THE PRIMARY INTERNATIONAL PLATFORM FOR HUMAN RIGHTS ADVOCACY, WITH SPECIALIZED AGENCIES SUCH AS THE OFFICE OF THE HIGH COMMISSIONER FOR HUMAN RIGHTS (OHCHR) AND TREATY BODIES MONITORING COMPLIANCE. INSTRUMENTS LIKE THE INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS (ICCPR) AND THE

CONVENTION ON THE ELIMINATION OF ALL FORMS OF DISCRIMINATION AGAINST WOMEN (CEDAW) ESTABLISH LEGAL NORMS THAT GUIDE STATE BEHAVIOR.

HOWEVER, ENFORCEMENT IS OFTEN HAMPERED BY POLITICAL CONSIDERATIONS AND LACK OF BINDING AUTHORITY. THE INTERNATIONAL CRIMINAL COURT (ICC) AIMS TO PROSECUTE EGREGIOUS VIOLATIONS LIKE GENOCIDE AND WAR CRIMES BUT FACES CHALLENGES RELATED TO JURISDICTION AND STATE COOPERATION.

REGIONAL BODIES, SUCH AS THE EUROPEAN COURT OF HUMAN RIGHTS AND THE INTER-AMERICAN COMMISSION ON HUMAN RIGHTS, PROVIDE ADDITIONAL AVENUES FOR REDRESS, ALTHOUGH THEIR INFLUENCE VARIES WIDELY.

Non-Governmental Organizations and Grassroots Movements

NGOs AND CIVIL SOCIETY ORGANIZATIONS ARE VITAL IN DOCUMENTING ABUSES, RAISING AWARENESS, AND PRESSURING GOVERNMENTS. GROUPS LIKE AMNESTY INTERNATIONAL AND HUMAN RIGHTS WATCH PUBLISH DETAILED REPORTS THAT INFORM POLICYMAKERS AND THE PUBLIC.

GRASSROOTS MOVEMENTS HAVE ALSO GAINED PROMINENCE, LEVERAGING SOCIAL MEDIA AND TRANSNATIONAL SOLIDARITY TO MOBILIZE SUPPORT. THE #MeToo MOVEMENT, FOR INSTANCE, HAS RESHAPED GLOBAL CONVERSATIONS ABOUT GENDER VIOLENCE, WHILE BLACK LIVES MATTER HAS SPOTLIGHTED SYSTEMIC RACISM IN MULTIPLE COUNTRIES.

THESE ACTORS OFTEN OPERATE UNDER SIGNIFICANT RISK, FACING HARASSMENT, LEGAL RESTRICTIONS, OR VIOLENT REPRISALS, PARTICULARLY IN AUTHORITARIAN CONTEXTS WHERE HUMAN RIGHTS DEFENDERS ARE TARGETED.

After a trial of eight years, Laurent Gbagbo was finally acquitted. The news of his unanticipated acquittal shocked the world. Later, that decision was overturned and transformed into freedom with binding and coercive conditions by the Appeals Chamber, which had succumbed to political pressure. The former president of Ivory Coast spent months of confinement in Belgium until the Appeals Chamber rebutted the prosecutor's appeal against his release and confirmed his total acquittal and that of Blé Goudé. He eventually went back to Ivory Coast on June 17, 2021. The trial of Laurent Gbagbo before the ICC, despite his acquittal (a tardy one), reflects a series of biases germane to international law and international justice, such as the victor's justice stance, the conflict between national law and international law, the question of sovereignty, and the issue of lawfare. The trial of Laurent Gbagbo, which was the hallmark of the selective international justice system embedded in unfairness, led to a historical landmark with his shocking acquittal, which led to the indictment of the International Court, whose fate has thus been sealed before history.
