- ****REINFORCING LEARNING:**** PRACTICE TESTS ENCOURAGE REVIEW AND REPETITION, WHICH ARE CRITICAL FOR RETENTION.

BY PRACTICING THESE SKILLS, CHILDREN DEVELOP NUMERICAL FLUENCY THAT SUPPORTS MORE COMPLEX MATH LATER ON.

2. BASIC MULTIPLICATION CONCEPTS

REVIEW AND DISCUSS ANSWERS TOGETHER

HOWEVER, ONE LIMITATION NOTED IS THE ABSENCE OF INTERACTIVE OR DIGITAL COMPONENTS IN THE TRADITIONAL CASE 21 TEST FORMAT. IN AN INCREASINGLY DIGITAL LEARNING LANDSCAPE, INCORPORATING TECHNOLOGY-ENHANCED ELEMENTS COULD ENHANCE ENGAGEMENT AND ACCESSIBILITY FOR DIVERSE LEARNERS.
