But Clark was more than a guaranteed double-double whenever he stepped on the floor. He was a deep-thinking trailblazer for players' rights. Clark often challenged coaches and owners on principle, much to the detriment of his career and NBA legacy, signing on as a named litigant in the seminal *Robertson v. NBA* antitrust case that smashed the player reserve system and jump-started the modern NBA. So lace up your high-top Chuck Taylors, squeeze into a pair of short shorts, and shake and bake back in time to the days of Wilt, Russell, Oscar, Jerry, Elgin, Hondo--and Archie.
