WHY WE SAY "BUT I TRUSTED YOU"

THE EXPRESSION "BUT I TRUSTED YOU" ISN'T JUST A LAMENT; IT'S A PIVOTAL EMOTIONAL RESPONSE THAT HIGHLIGHTS THE COGNITIVE DISSONANCE VICTIMS FACE.
