MANY PEOPLE OVERLOOK IMPORTANT ASPECTS LIKE INFLATION'S IMPACT ON SAVINGS, HEALTHCARE COSTS, OR HOW TO STAY SOCIALLY CONNECTED ONCE RETIRED. BY ENGAGING IN THOUGHTFUL CONVERSATIONS AND REFLECTING ON YOUR ASPIRATIONS, YOU'LL GAIN CLARITY AND CONFIDENCE IN YOUR RETIREMENT STRATEGY.

KEY FINANCIAL QUESTIONS TO ASK ABOUT RETIREMENT

WHEN SHOULD I START TAKING SOCIAL SECURITY BENEFITS?

SOCIAL SECURITY OFFERS DIFFERENT BENEFIT AMOUNTS DEPENDING ON WHEN YOU START CLAIMING. TAKING BENEFITS EARLY MIGHT REDUCE YOUR MONTHLY INCOME, WHEREAS WAITING CAN INCREASE IT. KNOWING THE IMPLICATIONS OF YOUR CLAIMING AGE IS ESSENTIAL TO MAXIMIZE YOUR LIFETIME BENEFITS.

QUESTIONS ABOUT MAXIMIZING CONTRIBUTIONS TO 401(k)s, IRAs, ROTH ACCOUNTS, OR OTHER TAX-ADVANTAGED PLANS CAN UNCOVER OPPORTUNITIES TO GROW YOUR NEST EGG EFFICIENTLY. TAX PLANNING IN RETIREMENT CAN SIGNIFICANTLY AFFECT HOW LONG YOUR SAVINGS LAST.

HEALTHCARE AND INSURANCE: CRITICAL RETIREMENT CONSIDERATIONS

Do I Have an Estate Plan in Place?

HAVING WILLS, TRUSTS, AND POWERS OF ATTORNEY IN ORDER PROTECTS YOUR ASSETS AND ENSURES YOUR WISHES ARE HONORED. THIS QUESTION PROMPTS YOU TO REVIEW OR CREATE LEGAL DOCUMENTS THAT SAFEGUARD YOUR LEGACY.

QUESTIONS TO ASK INCLUDE: WHEN IS THE BEST TIME TO START CLAIMING SOCIAL SECURITY BENEFITS? HOW ARE MY PENSION BENEFITS CALCULATED AND PAID OUT? CAN I WORK WHILE RECEIVING SOCIAL SECURITY OR PENSION BENEFITS? WHAT HAPPENS TO MY BENEFITS IF I DIE OR DIVORCE? ARE THERE SURVIVOR BENEFITS FOR MY SPOUSE OR DEPENDENTS?

WHAT ESTATE PLANNING QUESTIONS ARE ESSENTIAL BEFORE RETIREMENT?

ESSENTIAL ESTATE PLANNING QUESTIONS INCLUDE: DO I HAVE A WILL OR TRUST IN PLACE? WHO WILL BE MY POWER OF ATTORNEY AND HEALTHCARE PROXY? HOW CAN I MINIMIZE ESTATE TAXES FOR MY HEIRS? HAVE I UPDATED BENEFICIARY DESIGNATIONS ON ACCOUNTS AND INSURANCE? WHAT PLANS DO I HAVE FOR PASSING ON MY ASSETS TO FAMILY OR CHARITIES?

ADDITIONAL RESOURCES

WHAT ARE GOOD QUESTIONS TO ASK ABOUT RETIREMENT IS A CRUCIAL INQUIRY FOR ANYONE PREPARING TO TRANSITION INTO THIS SIGNIFICANT LIFE PHASE. RETIREMENT PLANNING IS A MULTIFACETED PROCESS THAT GOES BEYOND SIMPLY SAVING MONEY; IT ENCOMPASSES FINANCIAL SECURITY, LIFESTYLE CHOICES, HEALTHCARE CONSIDERATIONS, AND EMOTIONAL READINESS. ASKING THE RIGHT QUESTIONS CAN UNVEIL GAPS IN PLANNING, CLARIFY OBJECTIVES, AND ULTIMATELY CONTRIBUTE TO A MORE FULFILLING RETIREMENT EXPERIENCE.

AS THE GLOBAL POPULATION AGES, RETIREMENT PLANNING HAS BECOME INCREASINGLY COMPLEX. MODERN RETIREES FACE A VARIETY OF CHALLENGES INCLUDING FLUCTUATING MARKETS, LONGER LIFE EXPECTANCIES, AND EVOLVING HEALTHCARE NEEDS. THEREFORE, UNDERSTANDING WHAT TO ASK WHEN CONTEMPLATING RETIREMENT IS ESSENTIAL FOR MAKING INFORMED DECISIONS. FINANCIAL SECURITY: THE CORNERSTONE OF RETIREMENT PLANNING

ONE OF THE MOST PRESSING CONCERNS WHEN CONSIDERING RETIREMENT IS FINANCIAL STABILITY. WITHOUT A RELIABLE INCOME STREAM OR SUFFICIENT SAVINGS, RETIREES RISK OUTLIVING THEIR RESOURCES. THEREFORE, MANY GOOD QUESTIONS TO ASK ABOUT RETIREMENT REVOLVE AROUND MONEY MANAGEMENT AND INCOME SOURCES.

HOW MUCH MONEY DO I NEED TO RETIRE COMFORTABLY?

ESTIMATING THE AMOUNT NEEDED FOR RETIREMENT DEPENDS ON VARIOUS FACTORS INCLUDING EXPECTED LIFESTYLE, INFLATION RATES, AND HEALTHCARE COSTS. ACCORDING TO A 2023 STUDY BY THE EMPLOYEE BENEFIT RESEARCH INSTITUTE (EBRI), THE AVERAGE RECOMMENDED RETIREMENT SAVINGS TO REPLACE 80% OF PRE-RETIREMENT INCOME RANGES FROM \$1 MILLION TO \$1.5 MILLION FOR A 65-YEAR-OLD COUPLE. HOWEVER, THIS FIGURE CAN VARY WIDELY BASED ON GEOGRAPHIC LOCATION AND PERSONAL CIRCUMSTANCES.

ASKING THIS QUESTION ENCOURAGES INDIVIDUALS TO CONSIDER ESSENTIAL EXPENSES SUCH AS HOUSING, UTILITIES, FOOD, AND DISCRETIONARY SPENDING, AS WELL AS UNFORESEEN COSTS LIKE LONG-TERM CARE. IT ALSO HIGHLIGHTS THE IMPORTANCE OF CREATING A DETAILED BUDGET TO PROJECT FUTURE SPENDING ACCURATELY.

WHAT ARE MY SOURCES OF RETIREMENT INCOME?

ANOTHER CRITICAL FINANCIAL QUESTION ADDRESSES THE DIVERSITY AND RELIABILITY OF INCOME STREAMS DURING RETIREMENT. COMMON SOURCES INCLUDE SOCIAL SECURITY BENEFITS, EMPLOYER-SPONSORED PENSIONS, PERSONAL SAVINGS ACCOUNTS LIKE 401(K)s AND IRAs, AND INVESTMENTS. EACH HAS DISTINCT CHARACTERISTICS:

- **SOCIAL SECURITY:** PROVIDES A FOUNDATIONAL INCOME BUT USUALLY REPLACES ONLY ABOUT 40% OF PRE-RETIREMENT EARNINGS.
- **PENSIONS:** OFFER A STEADY INCOME BUT ARE LESS COMMON IN THE PRIVATE SECTOR TODAY.
- **PERSONAL SAVINGS AND INVESTMENTS:** REQUIRE CAREFUL MANAGEMENT TO AVOID DEPLETION, ESPECIALLY AMID MARKET VOLATILITY.

UNDERSTANDING HOW THESE SOURCES COMPLEMENT EACH OTHER AIDS IN ASSESSING THE SUSTAINABILITY OF ONE'S RETIREMENT INCOME.

WHEN SHOULD I CLAIM SOCIAL SECURITY BENEFITS?

THE TIMING OF SOCIAL SECURITY CLAIMS SIGNIFICANTLY IMPACTS MONTHLY BENEFITS. CLAIMING AT THE EARLIEST ELIGIBILITY AGE (62) REDUCES PAYMENTS, WHILE DELAYING UNTIL 70 INCREASES THEM. THIS DECISION INVOLVES WEIGHING IMMEDIATE FINANCIAL NEEDS AGAINST POTENTIAL LONG-TERM GAINS. GOOD QUESTIONS TO ASK ABOUT RETIREMENT INCLUDE EXPLORING HOW LIFE EXPECTANCY, HEALTH STATUS, AND FINANCIAL REQUIREMENTS INFLUENCE THE OPTIMAL CLAIMING AGE.

HEALTHCARE AND LONG-TERM CARE CONSIDERATIONS

HEALTHCARE EXPENSES REPRESENT ONE OF THE LARGEST AND MOST UNPREDICTABLE COSTS IN RETIREMENT. A COMPREHENSIVE RETIREMENT PLAN MUST ADDRESS THESE CONCERNS PROACTIVELY.

How Will I Cover Healthcare Costs After Retirement?

MEDICARE IS AVAILABLE TO MOST AMERICANS STARTING AT AGE 65, BUT IT DOES NOT COVER ALL MEDICAL EXPENSES. RETIREES OFTEN NEED SUPPLEMENTAL INSURANCE OR OUT-OF-POCKET FUNDS TO COVER SERVICES LIKE DENTAL CARE, VISION, AND LONG-TERM CARE. ACCORDING TO FIDELITY INVESTMENTS, AN AVERAGE RETIRED COUPLE CAN EXPECT TO SPEND OVER \$300,000 ON HEALTHCARE DURING RETIREMENT. ASKING THIS QUESTION PROMPTS RETIREES TO EVALUATE THEIR INSURANCE OPTIONS AND SAVINGS STRATEGIES TO MITIGATE HEALTHCARE-RELATED FINANCIAL RISKS.

What Are My Long-Term Care Options?

LONG-TERM CARE, WHICH INCLUDES ASSISTANCE WITH DAILY ACTIVITIES, IS OFTEN OVERLOOKED IN RETIREMENT PLANNING. QUESTIONS ABOUT THE AVAILABILITY AND AFFORDABILITY OF NURSING HOMES, ASSISTED LIVING, IN-HOME CARE, OR COMMUNITY-BASED SERVICES ARE ESSENTIAL. IT IS ALSO WORTHWHILE TO EXPLORE LONG-TERM CARE INSURANCE POLICIES AND THEIR BENEFITS AND LIMITATIONS.

Lifestyle and Personal Fulfillment in Retirement

RETIREMENT IS NOT SOLELY A FINANCIAL OR MEDICAL ISSUE; IT IS A PROFOUND LIFE TRANSITION THAT AFFECTS IDENTITY, PURPOSE, AND DAILY ROUTINES.

How Will Retirement Affect My Social Connections and Mental Health?

THE SOCIAL DIMENSION OF RETIREMENT IS OFTEN UNDERESTIMATED. LEAVING THE WORKFORCE CAN LEAD TO ISOLATION OR LOSS OF ROUTINE, IMPACTING MENTAL WELL-BEING. INQUIRING ABOUT STRATEGIES TO STAY SOCIALLY ENGAGED OR INVOLVED IN MEANINGFUL ACTIVITIES IS VITAL FOR EMOTIONAL HEALTH.

Legacy and Estate Planning

QUESTIONS ABOUT RETIREMENT SHOULD ALSO ENCOMPASS LEGACY CONSIDERATIONS—HOW RETIREES PLAN TO MANAGE AND TRANSFER THEIR WEALTH.
