IF NO PAGE NUMBER IS AVAILABLE, SUCH AS FOR SOME WEBSITES, JUST INCLUDE THE AUTHOR'S LAST NAME.

HANDLING MULTIPLE AUTHORS AND NO AUTHOR

- FOR TWO AUTHORS, LIST BOTH LAST NAMES: (SMITH AND JONES 112).
- FOR THREE OR MORE AUTHORS, USE THE FIRST AUTHOR'S LAST NAME FOLLOWED BY "ET AL.": (BROWN ET AL. 23).
- IF THERE IS NO AUTHOR, USE A SHORTENED TITLE OF THE WORK IN QUOTATION MARKS: ("CLIMATE CHANGE EFFECTS" 8).

CREATING THE WORKS CITED PAGE

THE WORKS CITED PAGE IS AN ESSENTIAL PART OF MLA FORMAT FOR WRITING A PAPER. IT PROVIDES FULL DETAILS OF EVERY SOURCE YOU REFERENCED IN YOUR TEXT, ENABLING READERS TO LOCATE THE ORIGINAL MATERIALS.
