TRAIN ADMINISTRATORS AND INTERPRETERS

PROPER TRAINING FOR HR PROFESSIONALS AND MANAGERS INVOLVED IN ADMINISTERING AND INTERPRETING THE QUESTIONNAIRE ENHANCES THE QUALITY OF INSIGHTS DERIVED AND SUPPORTS OBJECTIVE DECISION-MAKING.

REGULARLY REVIEW AND UPDATE THE TOOL

ADDITIONALLY, OVER-RELIANCE ON QUESTIONNAIRE RESULTS WITHOUT CONTEXTUAL CONSIDERATION CAN LEAD TO MISCLASSIFICATION. HIGH POTENTIAL IS A COMPLEX CONSTRUCT INFLUENCED BY ENVIRONMENTAL FACTORS, OPPORTUNITIES, AND SUPPORT SYSTEMS, WHICH A QUESTIONNAIRE ALONE CANNOT FULLY CAPTURE.
