He later became the king's liegeman, and it was for King Magnús that Sturla wrote the sagas of King Hákon and King Magnús.

Sturla served as lawman of all Iceland in the period 1272-77, and then as lawman for the north and west of the country until 1282. He died on 30 July 1284.
